FUND UPDATE

Ports Retirement Plan for the year ended 31 March 2018

This fund update was first made publicly available effective 30 June 2018.

WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Ports Retirement Trustee Limited prepared this update in accordance with the Financial Markets Conduct Act 2013.

DESCRIPTION OF THIS FUND

The fund has one diversified investment strategy with a broadly balanced strategic asset allocation between growth and income assets. The fund's aim is to achieve a real return (after inflation - as measured by increases in the consumers price index - and tax and investment expenses) in excess of 2.5% per annum over rolling 3 year periods.



WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the fund:

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.




EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Michael had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Michael received a return after fund charges were deducted of \$665.00 (that is 6.65% of his initial \$10,000). No other charges were deducted. This gives Michael a total return after tax of \$665.00 for the year.
